The costs that SCE seeks to recover in the application are not funded through existing rates. If the CPUC approves these requests, it will impact your monthly bill.

Why is SCE requesting this rate increase?

California saw unprecedented wildfires across the state in 2017, which was then the most destructive wildfire year on record and included the Thomas Fire in SCE's service area. SCE incurred costs to resolve litigation arising from the Thomas Fire and subsequent debris flow events in Montecito. In California, courts require utilities to pay for property damage and other costs resulting from fire caused by their facilities, as determined by a fire investigative agency, even if they operated their systems prudently. The CPUC then reviews the costs to ensure that it would be just and reasonable to pass those costs on to customers.

SCE also incurred costs to restore service to customers and to repair, replace, or restore damaged utility facilities. The CPUC authorized SCE to record these costs in its CEMA and seek cost recovery at a later date.

SCE has taken on significant debt to pay costs associated with these events. SCE is seeking cost recovery to pay this debt and reduce borrowing costs for ongoing operations.

How could this affect my monthly electric rates?

If the CPUC approves SCE's request to recover claim payments and legal fees recorded in the WEMA, SCE will file a new application to finance those costs through the issuance of recovery bonds. This would reduce the customer rate increase compared to traditional utility ratemaking. SCE estimates that it would recover costs in electric rates over a 30-year period beginning in 2026⁵. While the final rate impact would depend on the terms of the recovery bonds, SCE estimates the average residential monthly bill using 500 kWh per month would increase by approximately \$1.50 or 0.9% per month for those costs. By law, customers enrolled in the CARE and FERA programs¹ are exempt from paying the recovery charge associated with the financing order, and SCE anticipates CARE customers would be excluded from any bill impacts at all (subject to implementation of Assembly Bill 205, relating to the CARE discount methodology). SCE provides an illustrative rate and bill impact table for the WEMA costs below.

¹ The California Alternate Rates for Energy (CARE) program provides a discount of up to 30% on monthly electric bills if someone in your household participates in at least one eligible public assistance program or meets certain income criteria. The Family Electric Rate Assistance Program (FERA) provides an 18% discount for qualified households with three or more people. See www.sce.com/careandfera for eligibility and details.

If SCE's rate request relating to restoration costs recorded in the CEMA is approved by the CPUC, SCE would recover those costs in rates over a 12-month period. The average residential monthly bill using 500 kWh per month would increase by approximately \$0.24 or 0.1% per month for those costs. SCE provides a rate and bill impact table for the CEMA costs below.

The revenue associated with the CEMA costs would be recovered over twelve months following the issuance of a final decision in this proceeding. Any bill impact associated with the WEMA costs would not begin until after a financing order issues, which SCE anticipates will be in January 2026. These recovery periods may overlap for a period of a few months, during which the total bill impact for non-CARE or FERA customers would be approximately \$1.75 per month.

How does the rest of this process work?

This application will be assigned to a CPUC Administrative Law Judge who will consider proposals and evidence presented during the formal hearing process. The Administrative Law Judge will issue a proposed decision that may adopt SCE's application, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision with a different outcome. The proposed decision, and any alternate decisions, will be discussed and voted upon by the CPUC Commissioners at a public CPUC Voting Meeting.

Parties to the proceeding may review SCE's application, including the Public Advocates Office. The Public Advocates Office is an independent consumer advocate within the CPUC that represents customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. 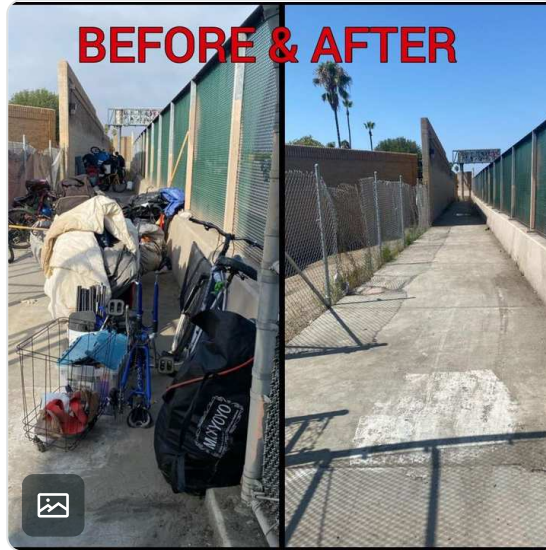

Real estate news: EV chassis maker Harbinger Motors shifts HQ to Garden Grove

Harbinger Motors, an electric vehicle chassis and axle maker, has leased a new facility in Garden Grove, with plans to shift its headquarters to Orange County from Gardena.

Colliers represented the landlord, Rexford Industrial, in the lease. Financial terms were not disclosed.

The new headquarters at 12821 Knott St. includes 165,171 square feet of manufacturing and office space.

Harbinger Motors will make electric light and medium-duty "scalable stripped chassis" at the facility, customizing design to customers' specifications, according to Colliers.

In a statement issued last September, Harbinger co-founder and CEO John Harris said the company was filling a niche in the exploding EV marketplace.

"Medium-duty vehicles serve as the backbone of the commercial transportation industry and are responsible for delivering tens of millions of packages and critical services every day," Harris said. "But while this industry has experienced tremendous growth, fleet customers today face acute shortages of gas- and diesel-powered vehicles, and any meaningful supply of production-ready EV offerings is still years out. We are solving this problem head-on."

Harris, who has extensive experience in battery technology, previously worked at Costa Mesa-based Anduril Industries as a principal mechanical engineer.

Harbinger said it expects to scale up its business “significantly” over the next five years. Its first vehicles are expected to be completed and in customers’ hands later this year, followed by full production launch in 2024.

Colliers said the building will undergo extensive renovations, with 40,000 square feet of office and engineering space carved out of the existing building.

Rexford bought the Knott Street property in 2019 and quickly made additions, including a 45,171-square-foot high bay area and 20,000 square feet of office space.

According to the county health care agency, the tally of new cases through Aug. 30 is 1,053. That's below last week's recent peak of 1,258.

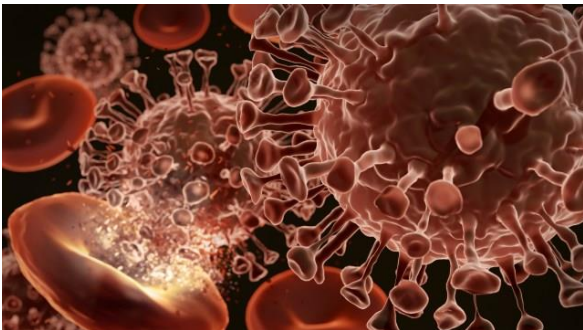
The number of COVID-19 cases to date is put at 732,652. The death toll is at 8,277 for Orange County.

In a win for cities, ACA 13 moves to the Senate

Sep 6, 2023

The California State Assembly today passed [ACA 13 \(Ward\)](#) with 56 aye votes. The Senate now has until Sept. 14 to pass the measure. But first, ACA 13 needs to clear the Senate Elections Committee, which could happen as soon as tomorrow.

The constitutional amendment would require future ballot measures that increase voter approval requirements to also pass by the same margin. Asm. Chris Ward introduced the measure, in part because an initiative to amend the state Constitution to significantly undermine local control, strip voters' rights and decimate tens of billions of dollars of local government tax and fee revenues qualified for the November 2024 ballot.

The League of California Cities threw its weight behind ACA 13, working closely with sponsors Asm. Ward and Assembly Speaker Robert Rivas to get it to the Senate. Over the past few days, city officials from throughout the state showed their support for the measure by calling their assembly members. They were joined by a coalition of [local government, teachers, labor, and nonprofit organizations](#).

"ACA 13 is a common-sense proposal that protects local decision-making and our cities' ability to deliver critical services to residents," said Carolyn Coleman, Executive Director and CEO of the League of California Cities. "No city leader wants to make tough decisions like cutting fire services, and this legislation is an important tool to help us protect the necessary revenue to fund such services."

Earlier this year, a group of the state's biggest corporations — under the umbrella of the California Business Roundtable (CBRT) — placed the [Taxpayer Protection and Government Accountability Act](#) on the November 2024 ballot. The initiative would undermine local control over resources needed to provide essential services. It would even retroactively cancel some measures approved by the voters.

Multiple groups have tried to raise voter thresholds in the past. However, the CBRT initiative is in the extreme. It would put billions of dollars in revenue at risk, open the door for new lawsuits and bureaucracy, limit the voices of voters, and upend how cities administer fees. It would also cancel many measures already passed by the voters and impact state taxes.

In other words: The CBRT initiative could result in funding cuts to fire and emergency response, law enforcement, programs to address homelessness, and supportive service programs.

ACA 13 would ensure voters — not wealthy corporations or special interests — decide which taxes and services are right for their communities. It would only apply to future measures. Proposition 13, which limits property taxes, would not be affected. Nor would ACA 13 impact the current two-thirds vote requirement for special taxes.

"If a measure wants to lock in a two-thirds supermajority vote threshold, it should also have the support of two-thirds of voters," said [Asm. Chris Ward, ACA 13's author](#). "What's fair is fair."

Six days to go and nearly 1,000 bills left to pass

The end of the 2023 legislative cycle is in sight. Last Friday marked the second half of the Legislature's twice-yearly suspense file. When it comes to local governments, the second suspense file passed with few surprises and mostly beneficial results.

Measures related to bettering behavioral health care, stopping illegal fentanyl and overdose deaths, and restoring local control passed off suspense, as did several measures aimed at protecting local revenues. A few bad bills, including one that would create onerous new reporting requirements and another that would curb cities' towing powers, were also held.

Gov. Gavin Newsom also made it clear that, insofar as [bond measures go](#), his \$4.7 billion mental health bond was the one to rally behind. The remaining bond measures were either killed entirely or may be reconsidered next year. While some bad bills did slip through — most notably two measures that would limit local land use authority — cities still have time to stop them.

The rapid-fire suspense file process allows the appropriations committees to review the fiscal impact of any bills before they go to the floor for a full debate. Holding a bill on the suspense file is usually — but not always — a death sentence. Below is a breakdown of the top bills that made it off suspense and those that met a grisly end.

Community Services

With the number of unhoused Californians rising, the Governor and Legislature have prioritized bills that take a comprehensive look at the state's behavioral health system and make targeted improvements. This includes the Governor's two-part legislative proposal, [SB 326 \(Eggman\)](#) and [AB 531 \(Irwin\)](#), which Cal Cities supports. The Governor [referenced Cal Cities' support](#) — and the support of several dozen mayors — in an August press release.

These measures would modernize the Mental Health Services Act and place a bond measure for 10,000 new community behavioral health beds and housing on the November 2024 ballot. This would ensure that California is better equipped to meet the needs of individuals experiencing severe behavioral health conditions and homelessness.

The two bills align with the League of California Cities' [advocacy priorities](#), which focus on strengthening state and local partnerships to connect individuals with the care they need through supportive services — including mental health and substance use treatment. Both SB 326 and AB 531 passed out of suspense and advanced to the floors of their respective houses.

Housing, Community, and Economic Development

Although Cal Cities already sidelined some of the most egregious land use bills this session, the appropriations committees ultimately passed a handful of bills that would limit local land use authority, silence community input, and empower the California Department of General Services to approve housing on state-owned property.

Chief among them is [SB 423 \(Wiener\)](#), which received bipartisan support. The measure seeks to expand multifamily housing streamlining requirements, bypass the California Environmental Quality Act (CEQA), and allow the state to determine local building requirements. Over 120 cities have joined Cal Cities in opposing SB 423.

Another Cal Cities-opposed bill, [AB 309 \(Lee\)](#), also cleared appropriations. This bill would create the Social Housing Program within the Department of General Service to build government-owned housing on leased state property or excess state-owned property. Cities would have little ability to regulate zoning or development standards — including floor area ratios, height limitations, and density requirements — on such developments.

Public Safety

Despite some [initial setbacks](#) earlier this year, most of Cal Cities' priority public safety bills are advancing to the Governor's desk. The Cal Cities-sponsored [AB 1168 \(Bennett\)](#) passed the Senate Appropriations Committee on a 7-0 vote. The bill would clarify a city or fire district's right to provide emergency ambulance services. Several fentanyl bills passed off suspense as well, including [AB 474 \(Rodriguez\)](#) and [AB 701 \(Villapudua\)](#). AB 474 would increase statewide efforts to combat fentanyl tracking. AB 701 would add fentanyl to the list of controlled substances for large-scale dealers. Cal Cities supports both measures. However, lawmakers did hold a bill that would have made it easier to permit cannabis businesses ([SB 508, Laird](#)) and one requiring the California Cannabis Authority to share delivery information with cities ([AB 687, Hart](#)). Cal Cities supported both measures. Other priority bills include:

Revenue and Taxation

With the [budget](#) in the rear-view mirror, the appropriations committees approved several measures with significant fiscal impacts to the state. However, many of these measures are unbudgeted and the Governor has signaled a [desire to veto bills](#) without a line item in this year's budget.

Perhaps the best news for cities is that [ACA 13 \(Ward\)](#) and [ACA 1 \(Aguiar-Curry\)](#) passed off suspense. ACA 13 would require any initiative constitutional amendment to conform with any increased voter threshold that it [seeks to impose](#) on future ballot measures. ACA 1 would reduce the approval threshold for public infrastructure and affordable housing bonds to 55% — the same threshold as school construction bond measures.

The two constitutional amendments passed out of the Assembly on Wednesday and are now headed to the Senate for a second vote. Cal Cities supports both measures.

However, it wasn't a complete victory. Lawmakers held the Cal Cities-sponsored [AB 972 \(Maienschein\)](#) despite its relatively small price tag. The bill would have coordinated, aligned, and streamlined local government assistance resources to ensure every

community has the same opportunity to compete for state funding opportunities by convening a statewide, cross-agency working group.

Transportation, Communications, and Public Works

Cal Cities scored a series of infrastructure victories, with two co-sponsored bills, [SB 706 \(Caballero\)](#) and [AB 400 \(Rubio, Blanca\)](#), both advancing to the Governor's desk. The measures would expand the use of design-build and progressive design-build delivery methods for local public work projects, saving cities time and money.

Cities could also notch another victory with [AB 334 \(Rubio, Blanca\)](#). If signed into law, AB 334 would allow cities to accept bids from design professionals for subsequent phases of public contracts. Current law has inadvertently and inappropriately limited the pool of qualified design professionals that cities can accept bids from. Cal Cities' Public Works Department provided input on the bill's language.

A parking violations and anti-towing bill, [AB 1082 \(Bryan\)](#) was held in suspense for additional negotiations. Cal Cities opposed the measure, as it usurped cities' authority to manage their streets and secured several amendments to water the bill down.

An effort to expand broadband, [AB 41 \(Holden\)](#), advanced off suspense to the Senate Floor with amendments. The bill would update certain anti-discrimination requirements to increase access to video and broadband services in low-income and unserved communities.

Governance, Transparency, and Labor Relations

In a win for cities, the problematic [AB 1713 \(Gipson\)](#) was held in suspense. The bill would have saddled cities that receive federal funds with onerous reporting requirements if the funds have an expiration date. Although the bill's author made several attempts to address Cal Cities' concerns, the measure still would have placed an unnecessary burden on local agencies.

California's [hot labor summer](#) also shows no signs of cooling. [AB 1484 \(Zbur\)](#) and [AB 504 \(Reyes\)](#) both moved off the suspense file. Cal Cities opposes the bills since they

would make it harder to provide essential services. AB 1484 would allow temporary employees to be automatically included in the same bargaining unit as permanent employees at the request of the union. AB 504 would make sympathy striking and honoring the picket line a human right.

Although most governance bills passed with only minimal amendments, two bills received major changes. Cal Cities is evaluating the significant amendments to [AB 764 \(Bryan\)](#) and [SB 553 \(Cortese\)](#). AB 764 would make several changes to the FAIR Maps Act, which governs how cities with district-based elections can draw their district maps. SB 553 would make changes related to workplace violence, workplace violence prevention plans, and temporary restraining orders.

Other priority bills include:

Environmental Quality

Two notable environmental bills passed out of suspense and are on their way to their respective floors for a full vote. [AB 1526](#), authored by the Assembly Committee on Natural Resources, would require plastic producers to schedule and remit funds owed to a local government to cover the cost of last year's [landmark single plastic reduction use law](#). Cal Cities supports AB 1526.

[SB 751 \(Padilla\)](#) would require specific provisions in local service contracts that allow cities to maintain solid waste services during a workforce labor dispute and take administrative action to ensure that such services are maintained. Cal Cities had previously supported the measure. However, it adopted a neutral position after the bill was narrowed to focus only on *force majeure* provisions and expanded to all cities. In a blow to climate change mitigation efforts, legislators held [AB 573 \(Garcia\)](#). The Cal Cities-supported measure would have allowed some cities to comply with the state's recovered organic waste requirements by procuring California-derived organic waste products from out-of-state facilities.

City leaders have just a few weeks left to make their voices heard in the Capitol. Lawmakers have until Sept. 14 to get their bills passed and onto Gov. Gavin Newsom's desk. The Governor then has until Oct. 14 to sign or veto any measures.

In addition, as Congress nears the end of the current fiscal year on [September 30th](#), they will need to adopt appropriations bills for the next fiscal year or a continuing resolution in order to avoid a government shutdown.

KEY LEGISLATION OCCOG IS WATCHING

The OCCOG Board of Directors has taken positions on a number of bills of interest in the 2023-2024 Legislative Session to date. Below is a brief update on a few of the still active major bills we have been watching over the course of the session.

AB 6 and 7 (Friedman) OPPOSE

Together, AB 6 and 7 by Assembly Member Friedman are a reintroduction of concepts from last session that seek to link transportation funding to the State's climate goals in a much more significant way. The author has embarked on a stakeholder process to help address concerns regarding these bills and work towards consensus. AB 6 was held in the Senate Transportation Committee and is now a two-year bill eligible to be considered in 2024. AB 7 is on the Suspense File pending before the Senate Appropriations Committee.

AB 701 (Villapudua) Controlled substances: fentanyl SUPPORT

AB 701 adds fentanyl to same sentencing and fine provisions applied to heroin and cocaine, including imprisonment of up to 4 years for the sale or purchase of these drugs as well as additional terms and fines. In support of providing our local agencies with tools to fight this crisis, AB 701 is on the Suspense File pending before the Senate Appropriations Committee.

AB 744 (Carrillo, D-Palmdale) California Transportation Commission: data, modeling, and analytic software tools procurement SUPPORT

AB 744 would require the California Transportation Commission to acquire public domain or procure commercially available or open-source licensed data, modeling, and analytic software tools to support the state's sustainable transportation, congestion management, affordable housing, efficient land use, air quality, and climate change strategies and goals. This bill would also authorize the commission to provide a direct allocation of funding to local agencies for the above purposes. This bill improves partnerships with the State and provides resources to smaller jurisdictions to perform the data analysis needed to adequately compete for funding. AB 744 is on the Suspense File pending before the Senate Appropriations Committee.

AB 914 (Friedman, D-Glendale) Electrical infrastructure: California Environmental Quality Act: review time period SUPPORT

AB 914 would require a state agency, acting as the lead agency, to complete its environmental review for an electrical infrastructure project and to approve or deny the project within 2 years of the submission and acceptance of a complete application. If the

state agency fails to meet this time period, the bill would require the state agency to submit to the Legislature a report setting forth the reasons for why the review could not be completed within the time period and identifying potential impacts to the electrical system that could result from the delay. AB 914 streamlines CEQA to help meet the State's housing, transportation, and environmental goals. AB 914 is on the Suspense File pending before the Senate Appropriations Committee

AB 976 (Ting) Accessory dwelling units: owner occupancy requirements **OPPOSE**

AB 976 removes the ability for local agencies to institute an owner occupancy requirement on properties where an Accessory Dwelling Unit (ADU) is present. This bill is contrary to our adopted Legislative Policy Guidelines which promote providing local jurisdictions with additional tools and funding while preserving local authority to address housing production, affordability, and homelessness challenges. AB 976 is currently on the Senate Floor.

SB 423 (Wiener, D-San Francisco) Land use: streamlined housing approvals: multifamily housing developments **OPPOSE**

SB 423 removes the sunset date for SB 35 (Chapter 366, Statutes of 2017), which is currently set to sunset on [January 1, 2026](#). This bill also authorizes the State Department of General Services to act in the place of a local agency related to the ministerial review process for development on property owned by or leased to the State. OCCOG opposes SB 423, consistent with the adopted Legislative Policy Guidelines which oppose policies that usurp local zoning authority or that favor a "one size fits all" approach to housing development. SB 423 is on the Suspense File pending before the Senate Appropriations Committee.

SB 537 (Becker, D-San Mateo) Open meetings: multijurisdictional, cross-county agencies: teleconferences **SUPPORT IF AMENDED**

SB 537 expands current remote participation opportunities for public meetings by allowing a board member to participate in a meeting remotely if they are more than 40 miles away from the location of the in-person meeting and participate from a publicly accessible building. In many areas of the state, travel time is affected by a number of factors – some of which have very little to do with physical distance from a particular location. Along with regional partners, OCCOG adopted a position to request amendments to SB 537 to reflect 30 minutes or more of travel time rather than an arbitrary distance of 40 miles. OCCOG supports SB 537 if amended to allow local agencies more flexibility with conducting official meetings virtually. SB 537 is pending on

the Assembly Floor.

SB 617 (Newman, D-Fullerton) Public contracts: progressive design-build: local and regional agencies: transit **SUPPORT**

Current law authorizes specified local agencies to use the progressive design-build process for up to 15 public works projects in excess of \$5,000,000 for each project that treats, pumps, stores, or conveys water, wastewater, recycled water, advanced treated water, or supporting facilities. SB 617 would extend these provisions for up to 10 public works projects more than \$5,000,000 for each project. This bill provides expanded design-build authority for infrastructure construction for our regional transportation partners. SB 617 is pending concurrence on the Senate Floor.
